Meeting: October 10, 2019

Chairman Mr. Ralph McCay ordered the regular called meeting of the Madison County Board of Assessors to order at 5:30 p.m. October 10, 2019 in the Public Meeting Room of the Madison County Government Complex. In attendance were Ralph McCay, Lynn Hix & Michael Baker. Also in attendance were Robin Baker & Gary Kappeler.

Old Business:

Motion was made by Mr. Lynn Hix to approve the minutes from the September 12, 2019 regular business meeting. Mr. Ralph McCay seconded the motion. Motion passed with 2-0 consent. Mr. Michael Baker abstained from voting since he was not present for that meeting.

New Business:

A refund request was made by Dennis & Arlesia Coile in the amount of approximately \$120.00 for parcel 0080-026 for the 2018 & 2019 digest years. The request was made due to a homestead exemption that inadvertently was removed from the property due to a new deed adding Arlesia to the property.

Motion was made by Mr. Michael Baker to approve the refund request for both years for Dennis and Arlesia Coile for parcel 0080-026. Mr. Lynn Hix seconded the motion. Motion passed with unanimous consent.

Appeals:

Motion was made by Mr. Lynn Hix to approve a reduced value of \$1,875.00 for the motor vehicle appeal made by Anita Vaughn. This motion was made following a visual inspection by the assessor's office of the 2006 Honda Odyssey. The original state title transfer value was \$3,575.00. Mr. Michael Baker seconded the motion. Motion passed with unanimous consent.

Motion was made by Mr. Lynn Hix to approve a reduced value of \$13,662.00 for the motor vehicle appeal made by Vanessa Poole. This motion was made following a visual inspection by the board of the 2015 Dodge Challenger. The original state title transfer value was \$20,300.00. Mr. Michael Baker seconded the motion. Motion passed with unanimous consent.

Motion was made by Mr. Michael Baker to deny any decrease for the motor vehicle appeal made by William Dale Gray. This motion was made following a visual inspection by the assessor's office of the 2006 Dodge Durango. The original state title transfer value was \$3,500.00. Mr. Lynn Hix seconded the motion. Motion passed with unanimous consent.
