Meeting: 09/10/09

Chairman Ralph McCay Jr. ordered the regular called meeting of the Madison County Board of Tax Assessors to order at 5:30 p.m. September 10, 2009 in the public meeting room of the Madison County Government Complex. In attendance were Janis Ellis, and Lynn Hix. Also in attendance were Robin Baker and Vicky Krieg.

Old Business:

Motion was made by Janis Ellis to approve minutes from the August 19, 2009 regular business meeting. Lynn Hix seconded the motion. Motion passed with unanimous consent.

New Business:

Motion was made by Janis Ellis to recommend a refund for Peggy Kingman & Sylvia Strickland 0042-052. They purchased the property in 2005 and have been charged taxes for a mobile home that was removed before they purchased the property. The information was corrected for the 2009 digest and they requested a refund for 2006, 2007, and 2008. According to Tax Commissioner Louise Watson, the refund would be a total of \$904.53. Lynn Hix seconded the motion. Motion passed with unanimous consent.

Appeals:

Motion was made by Janis Ellis to go into executive session with County Attorney Mike Pruett, Robin Baker, and Vicky Krieg to discuss pending litigation. Lynn Hix seconded the motion. Motion passed with unanimous consent.
